

REGISTRATION REQUIREMENTS FOR REGULATED MEMBERS
Full Practising Class [CPSM General Regulation, s. 3.8]

CREDENTIALS:

1. A medical degree from a nationally approved faculty of medicine or a Doctor of Osteopathic Medicine degree from a school in the United States accredited by the American Osteopathic Association Commission on Osteopathic College accreditation.
2. Establish that he or she meets one of the following criteria:
 - A. certification from the CFPC,
 - B. certification from the Royal College in a specialty field of practice
 - C. certification from the Collège des Médecins du Québec;
 - D. holds affiliate status with the Royal College in a subspecialty
 - Successfully completed a Royal College subspecialty examination through the Royal College – Subspecialist Examination Affiliate Program and,
 - Completed an approved period of supervised practice
- b. graduated from the Faculty of Medicine before January 1, 1994 and successfully completed one of the following postgraduate training requirements:
 - A. a 12-month rotating internship in a university teaching program acceptable to the College that contains at least eight weeks each of general medicine and general surgery, and at least four weeks each of pediatrics, and obstetrics and gynecology;
 - B. one year of straight, mixed or family medicine internship, after having satisfactorily completed an undergraduate clinical clerkship that:
 - i. is in a medical school recognized by the Committee on Accreditation of Canadian Medical Schools or the Liaison Committee on Medical Education of the American Medical Association and the Associate of American Medical Colleges,
 - ii. involves supervised responsibility for the care of patients,
 - iii. is at least 40 weeks in duration:
 - a. excluding holiday time,
 - b. including those clerkships regularly scheduled for all students and those chosen as elective, and
 - c. excluding non-clinical periods, whether prescribed or elective,
 - iv. includes at least eight weeks in each of medicine and general surgery, and at least four weeks in each of obstetrics and gynecology, pediatrics and psychiatry, and
 - v. is in the second half of the total undergraduate medical curriculum; or
 - c. was previously registered as a full registrant in good standing on the Manitoba Medical Register under subsection 17(3) of the former regulation as it read on February 16, 2012 or under section 4 of the *Registration of Medical Practitioners Regulation*, Manitoba Regulation 9/94 as it read on the day before it was repealed, as the case may be, and engaged in professional practice in Manitoba while so registered, or
 - d. for provisional registrants who have not achieved the credentials listed under 2.a, have a designation of successful, or partially successful in the [Manitoba Practice Assessment Program \(MPAP\)](#).

ADDITIONAL REQUIREMENTS:

1. If applicable, he or she has engaged in practice in the field or fields in which he or she intends to practice in Manitoba within the approved period of time.
2. If applicable, he or she met the continuing professional development activities he or she was required to complete in the immediately preceding 3 years in Canada.
