REQUIREMENTS FOR REGULATED MEMBER, PROVISIONAL REGISTRATION ACADEMIC – POST-CERTIFICATION TRAINEE [CPSM General Regulation, s. 3.14]

The provisional (academic – post certificate trainee) class is for the purpose of enabling an eligible post-medical degree trainee, who has successfully completed all of the requirements that would allow him or her to practise as a specialist in his or her home country, to pursue further clinical or research training in his or her specialty in Manitoba.

CREDENTIALS:

1. A degree from a nationally approved faculty of medicine or a Doctor of Osteopathic Medicine degree from a school in the United States accredited by the American Osteopathic Association Commission on Osteopathic College accreditation.

REQUIREMENTS CONFIRMED BY DEAN OF THE MANITOBA FACULTY:

- 1. A request signed by the applicant, the department head or division head, and the dean of the Manitoba Faculty (or the dean's designate):
 - a. confirming that the applicant:
 - A. completed the educational requirements for certification as a specialist as determined by the Royal College, or is recognized as a medical or surgical specialist in the jurisdiction in which he or she last practised before applying for registration;
 - B. meets the requirements for English language fluency set by Council;
 - C. is or will be legally entitled to work or study in Manitoba before engaging in professional practice.
 - b. describing the current and proposed professional practice;
 - c. providing the name of the physician and the division or department that will be responsible for supervising the applicant;
 - d. confirming that the applicant possesses training that is acceptable to the dean of the Manitoba Faculty (or the dean's designate) and that warrants admission to a postgraduate program of the Manitoba Faculty.

CONDITIONS

Conditions which may be imposed upon the registration include:

- 1. Restrictions on the field of practice, if appropriate.
- 2. Practice location restriction; the division or department and the person who will be responsible for supervising the applicant
- 3. Supervision restriction; the division or department and the person who will be responsible for supervising the applicant.

Other conditions may be imposed, depending upon the circumstances.

TIME LIMITED REGISTRATION

Provisional (academic – post-certification trainee) registration is for a period of not more than 24 consecutive months, unless extended by the Registrar for up to 12 additional months. An extension may be granted only if:

- 1. The physician provides a written request from the dean of the Manitoba Faculty (or the dean's designate) for an extension before the initial registration expires and sets out the reasons for the extension request.
- 2. The Registrar determines that there are exceptional or extenuating circumstances that merit an extension.

The Registrar must provide written reasons for his or her approval or refusal of the extension and, if the Registrar does not grant an extension, the physician has a right of appeal. [CPSM General Regulation, ss. 3.72 and 3.73]
